General Details.

Entry Forms:

You are requested to send the entry form duly filled in and having completed all details including Date of Birth of each participant. Each form should carry the signature and the seal of the head of the institution. The participation fee of Rs.500 /- may kindly be sent along with the details as per the enclosed Performa. In addition, towards boarding and lodging charges, a sum of Rs.100/- per participant per day shall have to be deposited by each school at the time of arrival either in cash or through bank draft in favour of Principal, The Hyderabad Public School, Ramantapur, Hyderabad.

Strength of the Team:

The participating teams should reach Hyderabad by the evening of 14th September '05, So that they can participate in the Opening Ceremony at 8 AM on 15th September 2005.

Arrangements will be made to receive the teams at the Railways Station. (Trains Coming from north viz., Delhi, e.g. By AP Express-the team is to get down at Secunderabad Station), Teams are requested to make arrangement for their return journey on their own please.

Reception :

Information containing details of boarding and lodging and other deemed information shall be provided on the arrival at the registration counter.

Meals :

Meals will be provided in the dining hall only during its fixed timings.

Discipline:

Chef-de-mission's of the respective teams will be responsible for the conduct, behaviors, turnout and discipline of their teams.

March past:

- a) Participation in the march past is must. Each school will march in its own school uniform only.
- b) Each School must send two flags, one flag (6 x 4 ft) in advance to the organizing secretary and another flag of the same size should be bought by the team for the march past.
- c) Award will be given on the basis of the march past, performance in the opening ceremony.

Identity Cards

Each participant including Chef-de-mission and coach shall carry the Identity Card in the interest of the safety, security and for identification. To sign by the respective Head of the Institution .One ID Card should be handed over at the registration counter for accreditation purpose on arrival.

IPSC FOOTBALL TOURNAMENT 2005

GENERAL RULES

1. The tournament will be called all India Inter Public School Football Tournament 2005 –06.
2. The tournament will be held from 15th September to 19th September 2005.
3. The entry fee is Rs.500/- (Rupees Five Hundred Only) per team.
4. A sum of Rs.100/- (Rupees One Hundred Only) will be charged per day per person towards the lodging and boarding.
5. Matches will be played on league cum knockout basis depending upon the number of teams and the matches will be played as per FIFA rules.
6. The duration of games shall be of two equal halves of 35 minutes each with an interval of 05 minutes. Extra time 7 – 1 – 7 minutes, will be allowed during knockout phase.
7. In the league phase the winner will be awarded two points, losers nil and in case of draw both the teams will share one point each.
8. The top two teams from each pool qualify for the next round.
9. If a team gives walk over, two points will be awarded to the other team.
10. If a match abandoned owing to any reason, it will be played afresh.
11. If in a pool, two teams are tied with equal points for the top position, the teams having the better goal average (goals scored for minus goals scored against) shall be the winner. In case of a tie the team having more goals scored for the next round.
12. The team if necessary may have to play more than one match in a day as fixed by the Organising committee.
13. The organising committee reserves the right to change the date, time and venue of a match if it becomes necessary.
14. The team must report at the ground 15 minutes before the scheduled start of the match.
15. The decision of the referee as per rules of the game shall be final.
16. The upper age limit of the player is restricted to 19 years as on 31st December 2005.
17. The teams are requested to bring their complete kit including football for practice of their players.
18. Protest if any will be lodged with the organising secretary in writing within 30 minutes after the match is over. No protest will be entertained against the decision of the referees. The decision of the jury of Appeal shall be final and binding to all.
19. The protest fees is Rs.500/- (Rupees Five Hundred Only) which shall be refunded if the protest is upheld.
20. You are requested to bring two school flags and give them to the Organising Secretary, which will be returned after the tournament to the teams in-charge of the respective school.
